Benefits You Can Use Now

All health plans on MNsure include these essential health benefits:

- Emergency services
- Hospitalizations
- Laboratory services
- Maternity and newborn care
- Mental and behavioral health services
- Outpatient services and doctor’s office visits
- Prescription drugs
- Prevention and wellness services
- Rehabilitative services and devices (to maintain daily functioning, or to recover from an illness or accident)

These benefits are available for you to use on day one of your policy.

- MNsure plans have no exclusions for pre-existing conditions.
- You cannot be denied coverage or charged a higher premium because of medical history.
- There are no annual or lifetime dollar limits on coverage.

Get covered for 2019

Open enrollment for 2019 coverage is November 1, 2018 - January 13, 2019. During this time, Minnesota residents can fill out an application and find out if they qualify for financial help.

Minnesotans eligible for Medical Assistance or MinnesotaCare can enroll year-round.

Many individuals or families, even those who are working, are eligible for financial help. If your maximum yearly income is below the amount listed below for your household size, you could qualify.
